## **Gregory Falls**

Attorney, Sherman & Howard L.L.C.

Greg Falls is a litigator in and serves as the managing member of Sherman & Howard's Phoenix office. He has more than 30 years of experience representing individuals, companies, state agencies, and government entities in federal and state court litigation, private arbitration proceedings, mediation, and administrative hearings. Greg was on the legal front lines of Arizona's efforts to mitigate the COVID-19 pandemic. A known authority in cannabis law, Greg was retained to represent the ADHS in its implementation and enforcement of the Arizona Medical Marijuana Act after its adoption in 2010. He has defended dozens of lawsuits challenging the validity of agency actions, supervised teams of lawyers in scores of enforcement proceedings against industry parties, and provided ongoing strategic and operational advice concerning the legality of the agency's actions under the act. Following passage of the Smart and Safe Arizona Act legalizing adult use of recreational marijuana in Arizona, Greg became counsel for ADHS in its implementation and enforcement of that act. He is well versed in the regulatory issues pertaining to marijuana and the laws and regulations governing the cannabis industry.

#### **Don Bischoff**

Don Bischoff began his law enforcement career as a Corrections Officer for the Mohave County Sheriff's Office in 1987, at the then new 241 bed county jail in Kingman, Arizona. Don graduated from the Arizona Law Enforcement Training Academy (ALETA) in 1988 and became a sworn deputy for the county. Don worked in patrol districts covering the entire county to include the Arizona Strip located in the far northwest corner of the State. Don remained a supervisor for 13 years in the patrol division for the Kingman district and supervised a special county-wide vehicle collision response team. In 2013 Don was promoted to Captain and was assigned as Jail Commander over the 260,000 square foot 708 bed adult detention facility. In October 2021, Don was re-assigned to special projects and is currently managing the Sheriff's Office new jail Re-Entry Program.

## **Victor Bowleg**

Victor Bowleg currently serves as the MacArthur Foundation Racial Justice Program Manager at the YWCA of Southern Arizona. He has a wealth of experience in the field of Conflict Resolution and in the recent past served as a Pima County Superior Court Mediator with the Family Center of the Conciliation Court and the Pima County Juvenile Court. In addition, Victor serves as an Adjunct Instructor at both Pima Community College and the University of Arizona. He earned both an M.A. in Rehabilitation/Mental Health Counseling from the University of Cincinnati College of Education and a J.D. from the University of Cincinnati College of Law in Cincinnati, Ohio. Victor is an active member of the Tucson community with a commitment to DEI. He recently made history when he was elected in 2023 as the first male President of the League of Women Voters of Greater Tucson. He has served as a volunteer in local organizations that include the National Institute for Civil Discourse. He has performed as an actor in the Tucson community and also served as a dramaturg in productions.

With a Cultural Competency background, Holly works to ensure that culturally responsive services are delivered to all including Health Choice members and that providers meet the language and unique cultural needs of those they serve.
